Online Admission Program for Post-Graduate MBA and MCA (Full Time) Courses Year 2025-26

Eligibility for Admission

For 95% seats of total sanctioned intake of Government / Grant-in-aid Institutions; 50% of total sanctioned intake and surrender seats of Management Quota of unaided Institutions; surrendered seats of few COE institutes: A candidate shall have obtained minimum qualifications as per prevailing admission rules from colleges/institutes located in Gujarat State.

For 5% seats of total sanctioned intake of Government/Grant-in-Aid Institutions:

A candidate shall have obtained minimum Qualifications as per prevailing admission rules from school and college/ institute located outside Gujarat in India.

Designated Cyber Space Centers Time: 11 AM to 5 PM for all working days

The online registration through internet is mandatory for participating in admission process. The aspiring candidate not having internet facility can avail the same at Cyber Space Centers designated by admission committee without paying any charges. Important Note for Appearing Candidates

Candidates, who have appeared in the qualifying examination and the result is awaited/pending, can also apply. However, the committee may issue a merit number/Admission in such a case on a provisional basis and admission will be finalised only if the candidate fulfils all the requirements & eligibility criteria as per the Government of Gujarat notification and submits all necessary documents in the manner deemed asked.

Minimum Qualification

• Mandatory Requirement:

The aspiring candidate shall have appeared in CMAT-2025 examination conducted by NTA (prescribed by AICTE) and shall have passed qualifying examination with minimum 50% (45% for SC/ST/SEBC/EWS categories) for MBA and MCA course.

MBA:

A candidate shall have obtained minimum Qualification as mentioned above and passed Bachelor Degree of minimum 3 years duration from recognized institutes/ universities duly stated in admission rules.

MCA:

A candidate shall have obtained minimum Qualification as mentioned above in accordance with prevailing admission rules and AICTE guidelines and passed qualifying examination of B.C.A. / B.Sc. (Computer Science) / B.Sc. (IT) / B.E. (CSE) / B.Tech. (CSE) / B.E. (IT) / B.Tech. (IT) or equivalent Degree or passed any graduation degree (e.g. B.E. / B.Tech. / B.Sc. / B.Com. / B.A. / B.Voc. / etc.) preferably with Mathematics, Business Mathematics or statistics at 10+2 level or, as the case may be, at Graduation level. For students having no Mathematics background compulsory bridge course will be framed by the respective University/ Institution and additional bridge courses related to computer subjects as per the norms of the concerned University.

Provision of Merit List

Merit shall be prepared on the basis of obtained **CMAT - 2025 score**, for more details refer to the admission rules on website.

Registration Process

- The online admission registration will begin from 03.06.2025 (03:00 PM) and will end on 24.06.2025 (5:00 PM).
- The candidate shall have to complete the registration process by uploading all relevant documents and paying registration fees (non-refundable) of INR 500/- for MBA or MCA course and INR 750/- for MBC (applying both MBA and MCA courses) through online mode only.
- Candidates seeking admission through admission committee for academic year 2025-26, shall have to register online to become
 eligible for further admission process. Please note that no other means of registration are available.
- Candidate during the process of registration shall give undertaking of accepting provisional admission till verification of all necessary documents for meeting eligibility criteria.
- There is no need to submit or verify any document in person. The entire admission process is completely online.
- The candidates and parents shall visit the admission committee website, and through Log-in to online admission portal through their User ID and password regarding various announcements, verification process and other guidelines on day to day basis.
- Tuition Fee Weaver (TFW) as supernumerary seats are not available for admission in MBA-MCA course as per AICTE norms.
- Candidates shall not be required to submit their original documents to institutes for the admission process.
