- The candidates shall have passed the qualifying examination. However in case of a candidate applying without being eligible his application will be summarily rejected and his application fee will be forfeited. No correspondence will be entertained in this regard.

- Before submitting the application form at ACPC office, an application fee Rs. 1000/- (non-refundable) in DD in favour of “GTERS-ACPC Fee” payable at Ahmedabad only shall have to be submitted at ACPC office, L. D. College of Engineering campus, Ahmedabad during **03.06.2025 to 18.06.2025** up to 5:00 p.m.
- After paying the application fee of Rs. 1000/- in DD at ACPC office, the duly filled Application form and form summary along with necessary self-attested documents, testimonials as mentioned in the application form shall be accepted during **03.06.2025 to 18.06.2025** up to 5:00 p.m. at the office of ACPC, L. D. College of Engineering Campus, Opp. Gujarat University, Ahmedabad.
- ACPC will not be responsible for any postal delay if the application is sent by post.
- Exam Admit Card/Hall Ticket for the applications received in complete will be issued by ACPC before the date of PG CET 2025 by email. The same shall be preserved and brought invariably at the time of PG CET 2025.
- The candidates who have passed qualifying examination with a mark sheet having CPI/Grade shall have to produce percentage equivalent certificate issued by university/institute from where they have passed the qualifying examination.
- The application of the sponsored candidate shall be submitted by the institute/authority sponsoring the candidate along with sponsorship letter. The sponsored candidate may submit one advance copy of the application to the admission committee. Further they shall have to attach copy of experience certificates and sponsorship certificate (standard format) in addition to other requisite certificates/documents.
- The caste certificate/Non-inclusion in creamy layer certificate for SEBC category/Medical Certificate for Physically Handicapped candidate /Ex-

serviceman category certificate /EWSs Certificate/Sponsorship certificate etc should be duly stamped, signed and issued by the authority empowered by Government of Gujarat.

- The candidate belonging to SEBC category shall have to produce to the effect of non-inclusion in Creamy Layer (in Gujarati) in addition to caste certificate; the validity of such certificate shall be as per the prevailing government norms.
- The candidate belonging to EWSs category shall have to produce the relevant certificate as per the prevailing government norms.
- Exam Admit Card/Hall Ticket and a photo identity proof must be produced at the time of the PG CET-2025 for verification. No candidate shall be permitted to appear in the PG CET-2025 without the valid Exam Admit Card/Hall Ticket. It must be preserved even after the PG CET-2025 and it should be presented at the time of counseling for admission.
- PG CET-2025 will be conducted by ACPC and the list of centers will be made available on website <https://acpc.gujarat.gov.in/>
- Incomplete application forms and application forms without self-attestation or incomplete documents or application fee receipt are liable to be cancelled.
- No separate call letter shall be issued for appearing in PG CET-2025/Counseling. The candidate shall have to remain present as per schedule mentioned in admission schedule at his own cost.
- The candidates shall have to bring all original certificates/testimonials/documents for verification at the time of counseling.
- The candidates, who are applying on equivalent qualification basis, shall have to submit the equivalency certificate issued by the University from where they have passed the qualifying examination, failing to do so their candidature shall not be considered for further admission process.
