<b>Q-01</b>	<b>What is the Meaning of DDCET?</b>
A-01	DDCET Means Diploma to Degree Common Entrance Test for admission in D to D Engineering/Pharmacy
<b>Q-02</b>	<b>What is the Need of DDCET Examination?</b>
A-02	<ul style="list-style-type: none"> <li>It is found that there is huge variation of students applied from the different boards and accordingly allocation of the seats is also varied, as the allocation of seats is based on the prorated of applicants from different boards. Accordingly, it can be summed up that particularly the students passing the diploma from small board are getting lesser in number of seats compared major board, leads students to dissatisfaction or feels they are not given equal chance of admission.</li> <li>Also, due to a greater number of Boards, distribution of seats and preparation of merit list has become more complicated. Moreover, many more private institution/Universities are increasing, as a result, many universities award diploma in engineering and therefore, distribution of seats and preparation of merit list has become more complicated in future.</li> </ul> <p>In order to avoid such discrepancy, ambiguity, dissatisfaction among the students, and to bring all applicant students on a common and equal platform, it is suggested to introduce an entrance examination - Diploma to Degree Common Entrance Test (DDCET)</p>

A-04	The registration fees for DDCET is INR 250 /-
<b>Q-05</b>	<b>When does registration process for DDCET start?</b>
A-05	DDCET registration process starts from 09.02.2026 to 30.03.2026
<b>Q-06</b>	<b>Who can apply for DDCET?</b>
A-06	<p>Eligibility for DDCET:</p> <ul style="list-style-type: none"> <li>Students who have passed in Diploma from a recognized Board/University in the state of Gujarat in <b>current/any previous year</b> as well as students who have passed in Diploma from a recognized Board/University across the country for 05% seats in Government Institutions (Candidates appearing in the last semester will be eligible.)</li> <li>Students having Bachelor of Science and Diploma Vocational from a recognized Board/University in Gujarat state as per provision of AICTE</li> <li>Students who have passed in Diploma from Board/University from outside State as per existing rules.</li> </ul> <p>Candidate shall be fulfilling the AICTE eligibility criteria</p>
<b>Q-07</b>	<b>Who will conduct DDCET?</b>
A-07	Gujarat Technological University is Nodal agency for conduction of examination.
<b>Q-08</b>	<b>How to select the exam centre?</b>
A-08	<p>Candidate has to give three choices of examination cities and district during the registration process.</p> <p>While selection of examination cities/ District: modification or alternation is not allowed at any circumstances after registration.</p>
<b>Q-09</b>	<b>What is the Marking System for DDCET ?</b>
A-09	<ul style="list-style-type: none"> <li>Two marks for each correct answer shall be awarded.</li> <li>For each wrong answer and more than one attempted answer minus 0.5 (half) mark shall be added on obtained marks.</li> <li>Unattempt answers will have zero marks</li> </ul>
<b>Q-10</b>	<b>How the merit list shall be prepared for D to D Admission?</b>
A-10	<p>Merit will be prepared on the marks obtained in the DDCET examination.</p> <p>If candidate is absent in examination then merit rank will not be generated.</p>

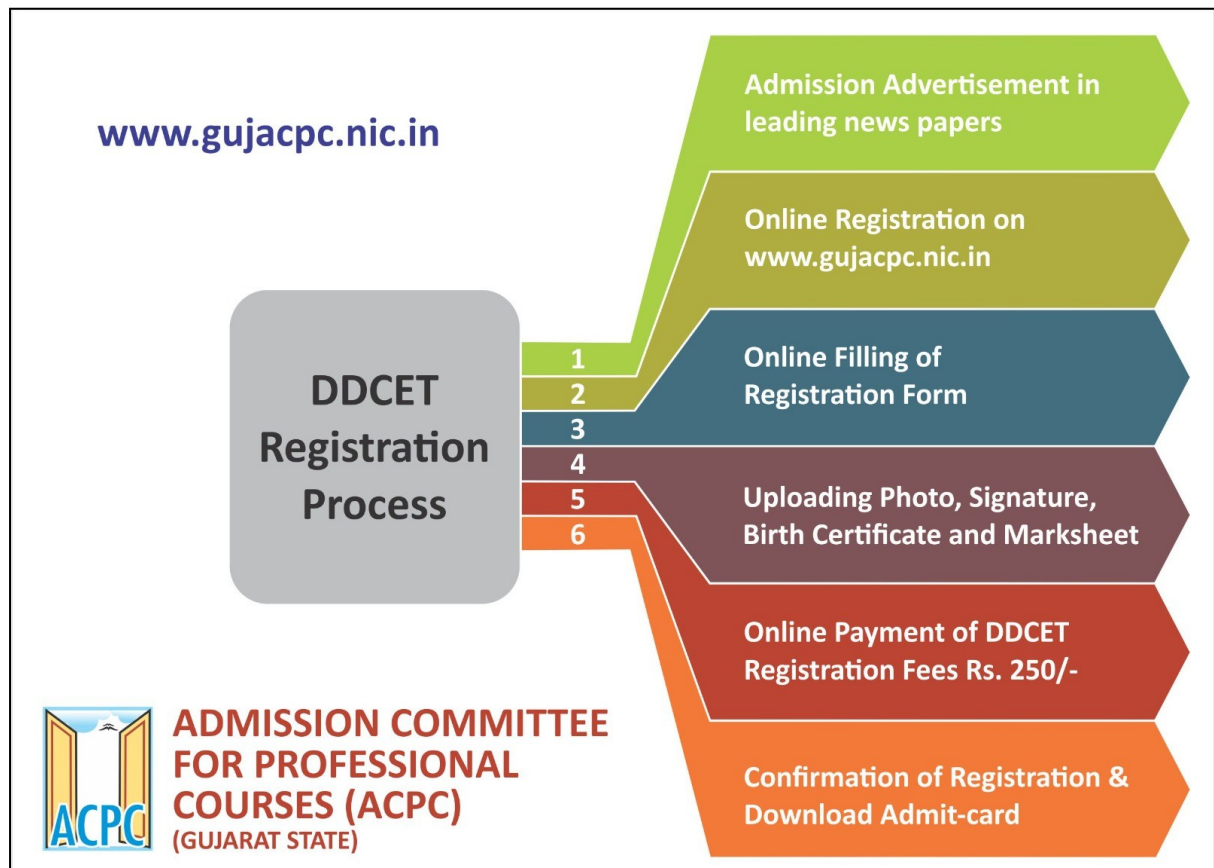


<b>Q-11</b>	<b>How merit is prepared if Students having equal marks in DDCET Exam?</b>
A-11	Students having equal marks for merit rank of DDCET in the said examination will be given priority as follows. (Key of Merit) <ul style="list-style-type: none"> <li>• Marks obtained in Section 01 (BE 01) for Engineering and BPH 01 for Pharmacy.</li> <li>• Marks obtained in Section 02 (BE 02) for Engineering and BPH 02 for Pharmacy.</li> <li>• Lowest deduction marks (Negative marks) in the said examination.</li> <li>• Section 01 (BE 01) for Engineering and BPH 01 for Pharmacy have the lowest cut off marks (Negative marks).</li> <li>• Section 02 (BE 02) for Engineering and BPH 02 for Pharmacy have the lowest cut off marks (Negative marks).</li> <li>• Date of Birth (Older will be consider first)</li> </ul>

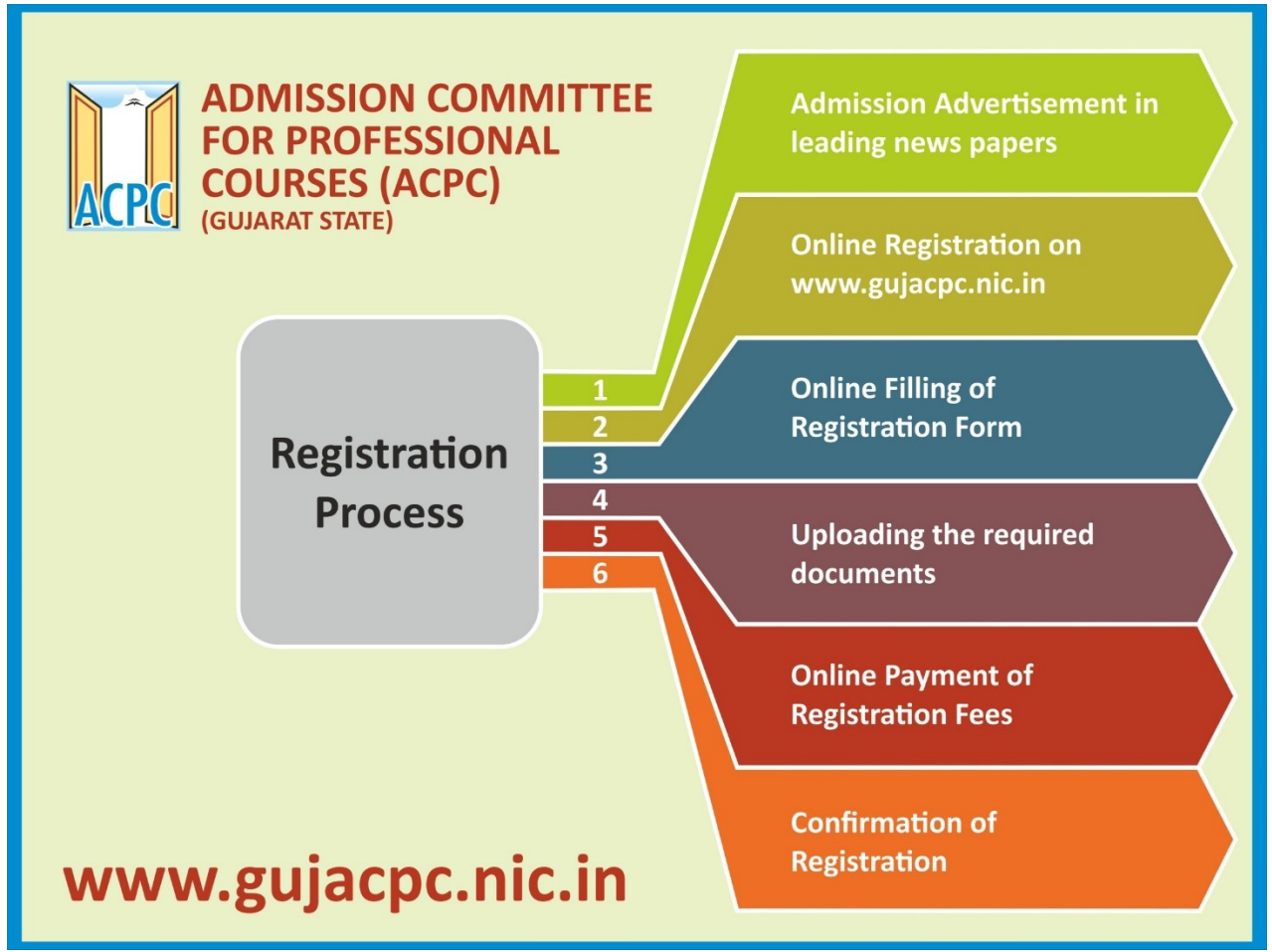

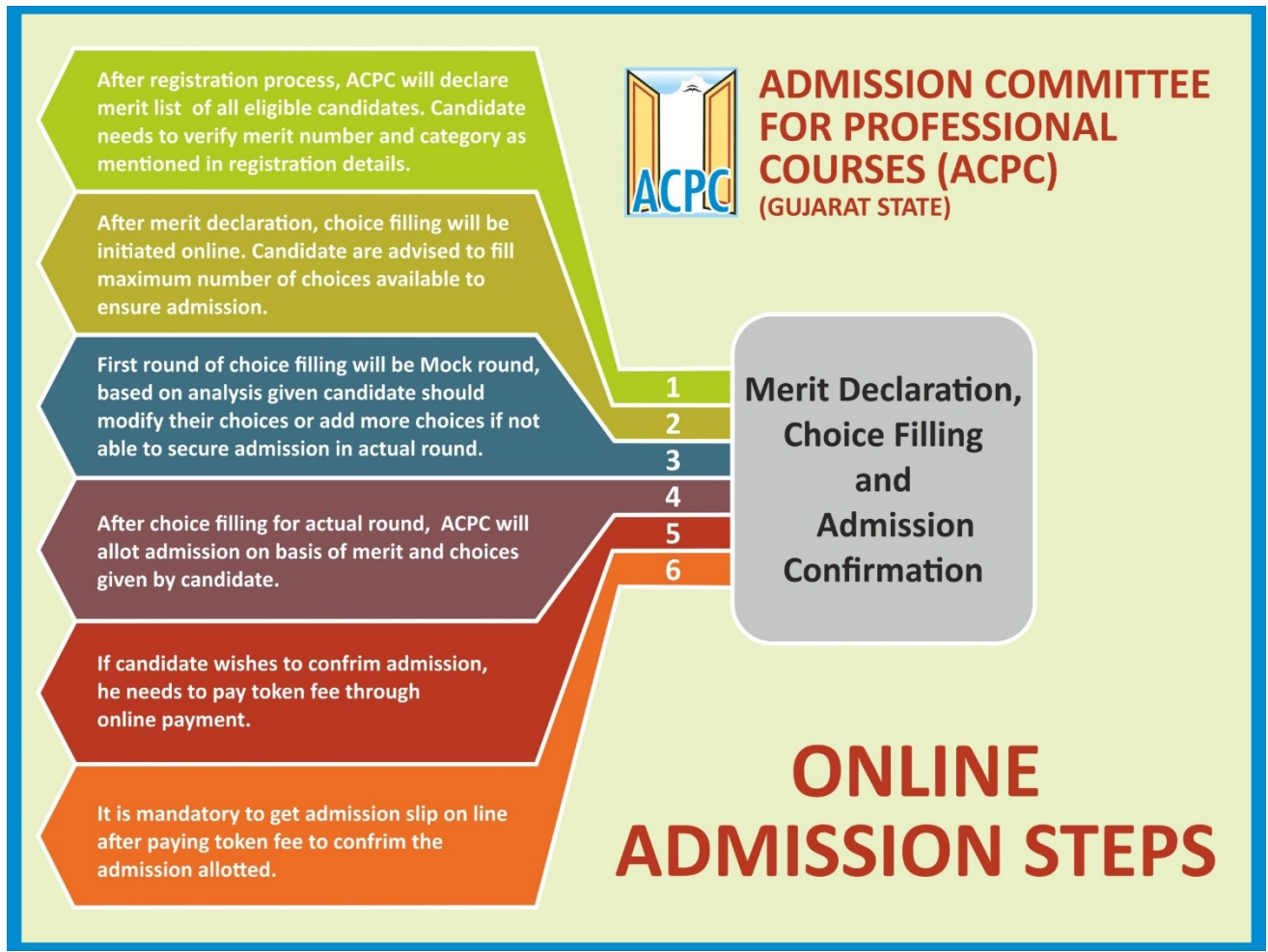


## **D to D Admission Registration Step After DDCET**
