



## Announcement for admission to First year of Post Graduate Engineering/Technology (M.E./M.Tech.) and Post Graduate Pharmacy (M.Pharm.) courses AY 2026-27

### Seats Bifurcation

**For 95% seats of total sanctioned intake of Government/Grant-in-aid Institutions and sanctioned intake of unaided Institutions:** A candidate have passed the qualifying examination from any of the Universities or institutes, **or** have passed Std. XII (10+2) pattern from any of the schools/ Diploma in Engineering from any of the Universities or institutes, situated **in the State of Gujarat.**

**For 5% seats of total sanctioned intake of Government/Grant-in-Aid Institutions:** A candidate have passed the qualifying examination from any of the Universities or institutes, **and** have passed Std. XII (10+2) pattern from any of the schools/ Diploma in Engineering from any of the Universities or institutes, situated **outside state of Gujarat.**

### Online Registration for M.E./M.Tech. & M.Pharm will start from 15.05.2026 from 3 PM onwards

### Minimum Qualification

- The candidate shall have passed B.E./B.Tech. or equivalent examination with minimum 50% (45% for SC/ST/SEBC/EWS candidates) at qualifying exam for M.E./M.Tech courses or B.Pharm. with minimum 55% (50% for SC/ST/SEBC/EWS candidates) at qualifying exam for M. Pharm. courses for seeking admission into post Graduate disciplines and its specializations as per Appendix-I of prevailing Post Graduate Engineering/Technology & Pharmacy Admission Rules 2020 and all its subsequent amendment duly fulfilling all prevailing AICTE/PCI norms.
- The candidates whose final semester results or result of any backlog in previous semester are awaited, can also apply but they shall have to pass qualifying examination as mentioned in Appendix-I of prevailing Post Graduate Engineering/Technology and Pharmacy Admission rules. However merit number in such cases will be allotted, if marksheet and provisional degree certificate of passing qualifying exam is furnished/uploaded within the scheduled time limit.

### Designated Cyber Space Centers

**Time : 11 AM to 5 PM for all working days**

**The online registration through internet is mandatory for participating in admission process.**

### Important Note for Document verification

During verification of candidate's online registration form if any discrepancy is found, a query will be generated and sent to the candidate's registered Mobile and Email. Candidates must upload the required documents to solve any such query. Thus, every candidate is informed to check in his/her Login frequently on <https://gujacpc.admissions.nic.in>, he/she can also visit any nearby designated Cyber Center, for uploading the required updated documents.

### PGCET-2026

- After admitting GATE/GPAT qualified candidates having valid GATE/GPAT qualifying marks, the unfilled seats, if any will be filled as per merit secured in PGCET-2026.
- The PGCET-2026 shall be conducted on **Dt. 20/06/2026 and 21/06/2026** at four different centers in Gujarat. The detailed PGCET-2026 schedule and other details are available on the committee's website.
- All Non-GATE / Non-GPAT candidates including sponsored (Non-GATE / Non-GPAT) shall have to appear in PGCET-2026 to become eligible for admission.

### Registration Process

- The online M.E./M.Tech. & M.Pharm admission registration will begin from 15.05.2026 (03:00 PM) and will end on 30.05.2026 (5:00 PM).
- The candidate shall have to complete the registration process by uploading all relevant documents and paying registration fees (non-refundable) of INR 1000/- per discipline applied for through online mode only.
- Candidates seeking admission through admission committee for academic year 2026-27, shall have to register online on <https://gujacpc.admissions.nic.in/> to become eligible for further admission process. Please note that no other means of registration are available.
- The candidates are advised to read carefully important instructions/guidelines before applying online (All available on committee's website). However in case of a candidate applying without being eligible, his/her application will be summarily rejected and his/her application fee will be forfeited. No correspondence will be entertained in this matter.
- All GATE/GPAT qualified candidates, Non-GATE/Non-GPAT candidates and all sponsored candidates shall have to register online to become eligible for further admission process. Please note that no other means of registration are available.
- The GATE/GPAT qualified candidates, who are qualified based on reserved category marks/score, shall be eligible only on reserved category seats as per the prevailing Post Graduate Engineering/Technology & Pharmacy Admission Rules 2020**
- There is no need to submit or verify any document in person. The entire admission process is completely online.
- The candidates are advised to visit the admission committee websites, and through Log-in to online admission portal using their User ID and password regarding various announcements, verification process and other guidelines on day to day basis.
- The sponsored seats shall be filled as per Govt. of Gujarat Post Graduate Admission Rules, Guidelines and AICTE Guidelines.
- Candidates shall not be required to submit their original documents to institutes for the admission process.**
