Instructions to Participate in Offline Vacant Seat Round for Government and Grant-in-Aid Institutes for
MPharm Courses for Admission Year: 2026-27
(Pursuant to Notice of committee dt. 10.09.2026)

In pursuant to notice dated 10.09.2026 for the admission to above referred vacant seats, candidates who have successfully filled the Google form within prescribed time limit and are in provisional merit list for the above referred admission process are hereby informed to remain present on **Counselling Date : 21.09.2026 and Reporting Time : 10.00 AM at ACPC Building, L.D. College of Engineering Campus, Opp. Gujarat University, Navrangpura, Ahmedabad. 380015.**

- Merit numbers given above are provisional, subject to verification of physical documents.
- All The candidates who registered for the offline round through the Google form link must report personally at the counselling venue by **10:00 AM on 21st September 2026**. Candidates who are absent or report late will not be considered for counselling/admission. ACPC will not make any telephone call or other communication to candidates who have not reported at the prescribed reporting time. No request or communication regarding absence or late arrival will be entertained by the Admission Committee.
- **Candidature of candidates reporting late for the schedule will automatically be considered as absent, and their merit will lapse. No requests shall be considered there after once your turn is over.**
- The candidates shall bring all original marksheets, Provisional Degree Certificate, GPAT score card, ACPC candidate profile, ACPC merit page (Download and print from **<https://acpc.gujarat.gov.in/merit list mpharm2026>**), valid category certificates and all other required documents with one photocopy of each at time of counselling. **No candidates shall be considered for counseling without all necessary supporting documents.** Candidates are required to bring all stationeries/accessories for photo-pasting, **and required amount of fees in Cash**, as per earlier notice dated 10.09.2026 regarding offline round.
- Aspiring candidate shall remain present in-person with tuition fees **₹1,500/- and ₹. 1000/- (in cash only)** towards non-refundable fee for registration. No other mode of payment will be allowed or no time will be provided for the same.
- This is provisional vacancy. The vacancies are to be filled as per the “Vacant Seats” provisions under the Master of Engineering and Technology and Master of Pharmacy Course(Regulation of Admission and Payment of Fees) Rules.
- **At any stage, if any candidate is found to have submitted incorrect documents, ineligible as per prevalent admission rules, his/her candidature will be summarily cancelled and his/her application fee will be forfeited. No correspondence will be entertained in this matter.**
- The vacancy is available on Notice of committee dt. 10.09.2026 on website. Candidates should check the vacancy before attending the Offline Round.
- All candidate shall take a note that, participating in the Offline Round does not guarantee admission. Vacant seats arising due to reshuffling may also be offered during the same round, subject to the condition that the allotment does not result in any merit violation.

- If a new seat is allotted and the previous admission is cancelled, the process for refund of fee for seat already allotted by this committee during online admission process, shall be as per rule 19 of prevailing notification of Government of Gujarat for admission to M. E./M. Tech./M.Pharm courses.
- Candidate shall understand the Impact on their existing admission • If a new seat is allotted to you in the Offline Round from Gov/GIA institutes, your previously confirmed admission issued from ACPC from an earlier round will be automatically cancelled. • Once a new seat is allotted, your previous admission will be cancelled even if you do not report to or join the newly allotted Gov/GIA seat. • If no seat is allotted to you according to your choices, your previously confirmed admission will continue and remain valid.
- **The candidates who have not applied in current offline admission round and willing to participate shall report to ACPC at 2.00 PM on 21.09.2026 with all original documents. (Note: Admission shall only be offered if seat remain vacant after counselling of Offline Vacant Seat Round Merit candidates.)**
