

Whenever, the complaint of missing children is received, the concerned SHO shall inform the same to the Para-Legal Volunteers. Attendance of the PLVs will be taken by concerned SHO. Concerned Police Stations would be providing infrastructure for proper sitting and working of PLVs in the police stations. Office stationery to the PLVs would be provided by DLSA from its own fund.

The above said Para-Legal Volunteers would be required to submit a report every week to DLSA regarding the work done during the week and any matter regarding special attention which comes to his/her notice in a prescribed format.
