OFFICE MEMORANDUM

Sub : Contributory Health Service Scheme for DAE
officers and staff stationed at Kalpakkam.

A proposal for extension of Contributory Health Service Scheme (CHSS) coverage to the employees of the DAE units at Kalpakkam has been under consideration in the Department for sometime. The President is now pleased to approve extension of the CHS Scheme of the Department in operation in Greater Bombay, as notified in the DAE Office Memorandum No.32(5)/67-Adm. dated April 21, 1975 as amended from time to time, mutatis mutandis to the officers and staff, their family members and dependents in the DAE establishments at Kalpakkam subject to the following :

- (1) The scheme will cover the following units/organisations:-
 - i) Indira Gandhi Centre for Atomic Research (IGCAR)
 - ii) Centralised Waste Management Facility (CWMF), Environmental Survey Laboratory (ESL) and Kalpakkam Reprocessing Plant (KARF) of Bhabha Atomic Research Centre.
 - iii) Madras Atomic Power Station (MAPS) of NPCIL
 - iv) General Services Organisation (GSO)
 - v) Units of Central Industrial Security Force at Kalpakkam
 - vi) Atomic Energy Education Society
- (2) Additional expenditure in the form of construction of hospital, dispensaries, etc. or creation of additional posts will not be incurred and the scheme will be managed with the existing sanctioned staff at Kalpakkam.
- (3) The scheme at Kalpakkam will be administered by the Director, IGCAR.

2. The procedural formalities for managing the scheme and for recognition of hospitals/doctors etc. outside Kalpakkam will be notified separately.

3. The expenditure involved will be debitable to the sub-head C-4 - Health - C-4(3) General Services Organisation, Kalpakkam subordinate to Major Head 3401-C-Atomic Energy Research for which the corresponding grant number for the current financial year 1993-94 is 84-Atomic Energy.

4. This issues with the concurrence of Member for Finance, Atomic Energy Commission.
