OFFICE MEMORANDUM

Subject: Provision of medical facilities to the  
Staff of DAE working in VEC Project at  
Calcutta.

The staff of this Department employed at VEC Project, Calcutta are governed by the Central Services (Medical Attendance) Rules, 1944. The provisions of the Rules were extended to the Gazetted Officers drawing pay more than Rs 500/-p.m. (in the pre-revised scales) and those belonging to the central civil services Class I and their families as a temporary measure under this department's O.M. No.10/5(4)/71-(H) dated December 13, 1971. These provisions have been extended from time to time upto december 31, 1978. The President is now pleased to relax the provisions of the said CSMA Rules further to the following extent:-

1. The gazetted officers who are in receipt of a pay of Rs 500/- or above (in the revised scale) and those belonging to the central civil services, class I and their families will be eligible to avail of the special facilities as applicable to non-gazetted staff as a regular arrangement.
  2. The Medical Officer, VEC Project will be the Authorised Medical Attendant for the purpose of these rules. The employees and their families will be eligible for free attendance and treatment at the site dispensary. The cost of medicines, if any, prescribed by the Medical Officer, VEC will be reimbursed to them if they are admissible under CS(MA) Rules.
  3. The Visiting Scientists/Professors/Fellows visiting VEC Project and stationed at Calcutta will be eligible for these facilities. Similarly the trainees stationed at Calcutta will be eligible for these facilities for themselves alone (and not for their families).
  4. In the case of members of the family of an employee of VEC who is transferred outside Calcutta in public interest, these facilities would be admissible for a period not exceeding two months from the date of transfer of the employee, provided they continue to reside at Calcutta.

5. The workcharged employees of VEC Project would also be eligible for these facilities provided they have been appointed on long term basis and on a monthly rate of pay.
