
**OFFICE MEMORANDUM**

Sub: Extension of CHSS medical facility to the employees of HRI at Allahabad and DAE Branch Secretariat & AMD (NR) at New Delhi-reg.

Reference is invited to Director (IR&W), DAE letter No.7/12/2014/IR&W/10397 dated 09.08.2016 and No.7/12/2014/IR&W/10709 dated 12.08.2016 on the above subject.


In this connection, the proposal received from DAE has been examined with an aim to how best it can be accommodated and after studying the feasibility, we are pleased to inform that, NPCIL will extend the medical facilities at par with NPCIL employees posted at New Delhi/NCR under CHSS to all DAE Branch Secretariat and AMD (NR) employees stationed at New Delhi on reciprocal arrangement basis. If additional AMAs, Base Hospitals, Tertiary Hospitals, Pathological Labs and Diagnostic Centres are required to be empanelled, the same may be done by NAPS with the approval of Station Director, NAPS.

To facilitate the reimbursement of expenses incurred on consultation of AMAs and purchase of medicines, the employees of DAE will submit the claims to the respective DAE Units and DAE Unit will reimburse the amount to the individual employees. The total expenses made in this regard will be raised to NAPS which will be adjusted against the per capita expenditure due from the DAE Unit by NAPS. The per capita expenditure will be calculated taking into consideration the amount spent by the DAE Units towards AMA expenses and procurement of medicines etc.

The proposal for extending CHSS medical facilities to the 275 beneficiaries both serving/retired DAE employees of HRI, Allahabad an Aided Institution under DAE has been also examined in detail. Since, NPCIL does not have any CHSS set up at Allahabad, it is not feasible on the part of NPCIL to extend the CHSS facility through NAPS at Allahabad.

As far as availability of CHSS facility in NPCIL Units is concerned; TM Site, RR Site, NAPS, Kakrapar Gujarat Site, Kaiga Site and KKNPP are providing CHSS facility to CHSS beneficiaries.

It is requested to kindly co-ordinate with SD, NAPS for further enrollment of employees of DAE Branch Secretariat and AMD (NR) stationed at New Delhi under CHSS of NAPS.
