**Sub : Clarification in respect of CHSS Rule no. 2.1.5**

-----

Department vide OM no. 7/55/94/CHSS/IR&W/37 dated 22/01/1998, instructed that 'although the Scheme framed is particularly meant for Mumbai, the same is extended mutatis mutandis to other places where the CHSS is in operation. This would mean that while all the ground rules and basic features of the Mumbai Schemes will be applicable to all these places, the special conditions and distinctive set up at each place as existing now would continue'.

4. CHSS Rule no. 2.1.5 provides that 'the employees of the Department having headquarters elsewhere than in Mumbai who visit Mumbai on tour/training/leave and members of their families will be entitled to the concession of OPD treatment only. Only in a medical emergency they may be hospitalised in the BARC Hospital'.

5. Though OPD and inpatient treatment in case of medical emergency, is extended to outstation CHSS beneficiaries by BARC Hospital, on leave/tour/training etc., instances have been brought to the notice of the Department that the same facility is not extended to officials/their family (covered under CHSS) by other outstation Units where CHSS exists.

6. In this regard, in terms of CHSS Rule no. 2.1.5, it is to inform that medical treatment may be extended to all the CHSS beneficiaries, who happen to be away from headquarters on account of tour/training/leave at any of the DAE Units, where CHSS facilities exist.
