Subject: Extension of the Contributory Health
Service Scheme (CHSS) of IGCAR/DAE to
the employees of DOS/ISRO stationed at
Madras - reg.

This Department made a proposal to the Department of Atomic Energy, Bombay, for the coverage of DOS/ISRO employees stationed at Madras under the CHSS of IGCAR/DAE in terms of the reciprocal arrangement existing between DOS and DAE. DAE, Bombay, has since issued the orders for such coverage vide O.M. No. 22/10/92/CHSS/IR&W/100 dated May 9, 1995. The procedural formalities for covering our employees stationed at Madras under the CHSS of IGCAR/DAE have been discussed with your officers, and in pursuance of these discussions, this Department has issued orders regarding the coverage of DOS/ISRO employees under the CHSS of IGCAR/DAE; a copy of the same is enclosed for your perusal.

2.1 As may be seen from this O.M. enclosed, (i) the medical claims from DOS/ISRO employees will be reimbursed by this Department, and (ii) IGCAR/DAE will directly book the expenditure incurred on behalf of DOS/ISRO employees to the head of account of SHAR Centre. In view of these, this Department feels that the contribution to be recovered from the DOS/ISRO employees on their admission to the CHSS of IGCAR/DAE need not be credited to IGCAR/DAE by the SHAR Centre.

2.3 The rate of contribution prescribed by this Department for the DOS/ISRO employees covered under its CHSS is 2% of the basic pay subject to a minimum of Rs. 20/- and a maximum of Rs. 120/-. IGCAR/DAE Scheme, however, stipulates a contribution of 1% of the basic pay. Recoveries at lesser rate of 1% of the basic pay for one set of employees of this Department would lead to many problems. To ensure uniformity, it is imperative that DOS/ISRO employees at Madras also contribute at the rates prescribed by this Department. Accordingly, we have issued orders, vide para 8.1 to 8.4 of DOS O.M. No. 3/1(8)/94-IV dated June 20, 1995, for the recovery of contribution from DOS/ISRO employees, which are in variance with the CHSS of IGCAR/DAE.

3. In the circumstances, I request you to agree to the retention by the SHAR Centre of the contribution recovered from the DOS/ISRO employees.
