Sub Promotion/Posting/transfer in the grade of Assistant (Level-7 in Pay Matrix).

The following promotion/posting/transfer in the grade of Assistant (Level 7 in Pay Matrix) is hereby ordered by the Competent Authority:

- vii) Shri R. Kishore, UDC, AMD, Bengaluru is promoted to the grade of Assistant and posted to BARC, Mumbai.
- viii) Shri Rajender Singh Yadav, UDC, AMD, New Delhi is promoted to the grade of Assistant and posted to AMD, New Delhi.
- ix) Shri Kishore Kumar Bhardwaj, UDC, AMD, Jaipur is promoted to the grade of Assistant and posted to DPS, Mumbai.
- x) Shri Gahuraj Rathod, PRA, NFC, Hyderabad is promoted to the grade of Assistant and posted to GSO, NRB, Tarapur.

- 2. The officials at S.No. (iii) to (x) will be on probation for a period of one year from the date of assumption of charge of the post of Assistant.
- 3. The transfer of the officials at S.No. (i) and (ii) will be on personal interest. They will not be eligible for transfer T.A. and other benefits.
- 4. The transfer/posting of the officials at S.No. (ii) and (viii) will be effective from 01.08.2020 and they may be relieved latest by 01.09.2020.
- 5. The order of promotion/transfer is to be effected within a period of 15 days from the date of issue thereof, subject to vigilance clearance. However, officials who are promoted are requested to convey their willingness or otherwise latest by 24.07.2020. Further, all the officials transferred outside their present station may be relieved <u>latest by 17.08.2020</u>, failing which, they will stand relieved/deemed to be relieved from the next working day. If they fail to report after relieving / deemed relieving, they will be treated as absenting from duty unauthorizedly and will be liable for disciplinary action besides non-drawal of salary and allowances.
- 6. If the transferred / promoted officials wish to avail any leave after the above-said date of relief, they have to first report to the unit to which they have been transferred and the leave will have to be invariably sanctioned by the leave sanctioning authority of that unit.
- 7. The details of relief / assumption of charge of the above officials may be intimated to the Department.
