## HOTIFICATION

In exercise of the powers conterred by the proviso to article 309 of the Constitution, the President hereby makes the following rules regulating the method or recruitment to the post of Deputy Controller of accounts in the Department of Atomic Energy, namely:-

- Short title and commencement: (a) These rules may be called the Department of Atomic Lnergy (Poputy Controller of Accounts) Recruitment Rules, 1989.
  - (h) They shall come into corce on the date of their publication in the Official Casatte.
- 2. Number of posts, Classification and scale of pay: The number of the said post, its classification and the scale of pay attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- The method of recruitment, age limit, qualifications etc.

  The method of recruitment to the said post, age limit,

  qualifications and other matters connected therewith shall be
  as specified in columns (5) to (14) of the said Schedule.

- Lisuali, ications: No person.
- (a) who has entered into or contracted a marriage with a person having a spouse living, or
- (b) who, having a spouse living, was entered into or contracted a marriage with a person.

shall be eligible for appointment to the said post, provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- power to relax: There the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing relax any of the provisions of these reles wit respect to any class or category of persons.
- relaxation of age limit and other concessions, required to be provided for the scheduled Castes, Scheduled Tribes.

  Ex-Servicemen and other special categories of persons in accordance with the orders issued by the Central Covernment from time to time in this rejard.
