OFFICE MEMORANDUM

Subject : Enhancement of Update Allowance from Rs.7,500/- to Rs.11,250/- per annum.

The undersigned is directed to refer to this Department O.M. No. 1/2/99-SCS/609 dated 13.08.2002 and O.M. No. 15/9/2004-R&D-II/25-A dated 2.1.2007 and subsequent O.Ms as amended / clarified from time to time.

2. Approval of the Department in consultation with Ministry of Finance, is hereby conveyed for enhancement of Update Allowance from Rs. 7,500/- to Rs. 11,250/- (Rupees Eleven thousand and two hundred fifty only) per annum, to the Scientific / Technical officer of the Department who are placed at Level-9 and below of 7th CPC Pay Matrix, and to all Technical, Administrative and Auxiliary categories of personnel of the Department of Atomic Energy (irrespective of their Levels in the Revised Pay structure of 7th CPC Pay Matrix) with effect from the financial year 2017-18.

3. Approval of the Department is also conveyed for enhancement of Update Allowance from Rs. 7,500/- to Rs.11,250/- (Rupees Eleven thousand two hundred fifty only) per annum, to the non-scientific staff of Aided Institutions viz. (1) Tata Institute of Fundamental Research (TIFR); (2) Tata Memorial Centre (TMC); (3) Saha Institute of Nuclear Physics (SINP); (4) Institute of Plasma Research (IPR); (5) Harish-Chandra Research Institute (HCRI); (6) Institute of Mathematical Sciences (IMSc) and (7) Institute of Physics (IOP), irrespective of their Levels in the Revised Pay Structure of 7th CPC Pay Matrix, with effect from the financial year 2017-18. However, this enhancement shall not be applicable to those Aided Institutions/Autonomous Bodies which have adopted the pay scale similar to those of the UGC or IISc/IITs.

4. The enhancement of Update Allowance shall be subject to the Terms and Conditions stipulated in the Department's O.M. dated 13.08.2002 and 02.01.2007 and as amended / clarified from time to time.

5. The expenditure will be debitable to the head "Salaries" of the concerned Units.
