ect Norms for the post of Principal Private Secretary (Scale of pay Rs.10000-15200)

Reference is invited to this Department notification No.20/1/2/99-CCS/302 dated 16.07.2001 regarding the Recruitment Rules for the post of Principal Private Secretary in the scale of pay of Rs.10000-325-15200 in the Department.

2. In terms of the above referred notification, Private Secretaries and Senior Personal Assistants in the scale of pay of Rs.6500-10,500 with 8 years regular service in the grade eligible to be considered for promotion as Principal Private Secretary in the scale of pay of Rs.10000-15200 in the Department. This Department vide Office Memorandum No.20/22(6)/2001-CCS/240 dated 17.05.2002, has since redesignated the posts of Senior Personal Assistant in the scale of pay of Rs.6500-10500 as Private Secretary (Non-Secretariat) in the same scale of pay and introduced a new grade of Senior Private Secretary in the scale of Rs.7500-250-12000 in the Non-Secretariat Offices under this Department. Considering these aspects it has been diecided by the competent authority to amend the norms for promotion to the post of Principal Private Secretary (Rs.10000-1520.0) under this Department as under :

(i) In column 11 regarding the method of recruitment, the existing envry will be substituted with the following : Promotion :

100% by selection from among the Senior Private Secretaries (R.3.7500-12000), Private: Secretaries (Rs.6500-10500) and Private Secretaries (Non-Secretariat) (R:3.6500-10500) in the Department, failing which on deputation.

(ii) In column 12 regarding the grades from which the promotion etc. will be made, the existing entry will be substituted with the following :

(a) Senior Private Secretaries (Rs.7500-12000) in the Department with a regular service of 6 years in the grade OR

Senior Private Secretaries (Rs.7500-12000) in the Department with a combined regular service of 8 years in the grades of Rs.7500-12000 and Rs.6500-10500.

(b) Private Secretaries (Rs.6500-10500) and Private Secretaries (Non-Secretariat) (Rs. 6500-10500) in the Department with a regular service of 8 years in the grade...

3. Action to incorporate necessary amendments in the existing Recruitment Rules and to notify the same under Article 309 is being taken separately. This order issued with the approval of the competent authority will come into force with immediate effect.

G.S.R. : In exercise of the powers conforred by the proviso to article 309 of the Constitution, the President hereby makes the following rules regulating the method of recruitment to the post of Principal Private Secretary, in the Department of Atomic Energy, Mumbai namely :-

1. Short title and commencement :- (1) These rules may be called the Department of Atomic Energy (Principal Private Secretary) Recruitment Rules, 2001.

(2) They shall come into force on the date of their publication in the Official Gazette:

Power to relax :- Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing relax any of the provisions of these rules with respect to any class or category of persons. 6. Saving : - Nothing in these rules shall affect reservations, relaxation of age limit and other concessions, required to be provided for the Scheduled Castes,/Scheduled Tribes, the Other Backward Class, the Ex-Serviceman and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.




