NOTIFICATION

In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules regulating the method of recruitment to the post of Administrative Officer-III in the Department of Atomic Energy, namely:-

Short title and commencement:

- [a] These rules may be called the Department of Atomic Energy (Administrative Officer-III) Recruitment Rules, 1988.
- [b] They shall come into force on the date of their publication in the Official Gazette.

2. Number of posts, classification and scale of pay:

The number of the said post, its classification and the scale of pay attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.

3. Method of recruitment. age limit. qualifications etc.

The method of recruitment to the said post, age limit, qualifications and other matters connected therewith shall be as specified in columns (5) to (]4) of the said Schedule.

4. Disqualifications: No person, -

- [a] who has entered into or contracted a marriage with a person having a spouse living, or
- [1] who, having a spouse living, has entered into or contracted a marriage with a person;

shall be eligible for appointment to the said post, provided that the Central Government may, if satisified that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax:

Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing relax any of the provisions of these rules with respect to any class or category of persons.

Nothing in these rules shall affect reservations, relaxation of age limit and other concessions, required to be provided for the Scheduled Castes, Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

 - Chief Controller of Accounts, Member Department of Atomic Energy or Internal Financial Adviser in any of the Department of Atomic Energy' Units in the grade not lower than Director to the Govt, of India

Sub: Recruitment Rules for the post of Administrative officer-III – reg.

The undersigned is directed to refer DAE Notification No.20/1/2/86-CCS/536 dated 04.08.1988 read with DAE Notification No.20/1/2/86-CCS/638 dated 14.08.1996 on the above subject.

2. The question of including the posts of Staff Relations Officer and Assistant Public Relations Officer in PB-2 Rs.9300-34800 Grade Pay Rs.4800 as feeder grades for promotion to the post of Administrative Officer-III has been under the consideration of the department. With the approval of competent authority, it has now been decided to include these posts as feeder grades for promotion to the post of AO-III with immediate effect as detailed below:

- i) Staff Relations Officer in PB-2 Rs.9300-34800 Grade Pay Rs.4800/Rs.5400 having a minimum of 8 years regular service in the grade.
- ii) Assistant Public Relations Officer in PB-2 Rs.9300-34800 Grade Pay Rs.4800/Rs.5400 having a minimum of 8 years regular service in the grade.

 Public Relations Officer in PB-3 Rs.15600-39100 Grade Pay Rs.5400 having a minimum of 8 years combined regular service in the grades of Public Relations Officer in PB-3 Rs.15600-39100 Grade Pay Rs.5400 and Assistant Public Relations Officer in PB-2 Rs.9300-34800 Grade Pay Rs.4800/Rs.5400.

3. Action is being initiated to incorporate the above norms in the Recruitment Rules under Article 309 of the Constitution which will be notified in due course.
