NOTIFICATION

In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules regulating the method of recruitment to the post of Assistant in the Department of Atomic Energy, namely:-

- Short title and commencement:
 - [a] These rules may be called the Department of Atomic Energy (Assistant) Recruitment Rules, 1988.
 - [b] They shall come into force on the date of their publication in the Official Gazette.
- Number of posts, classification and scale of pay:
 The number of the post, its classification and the scale of pay attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.

3. Method of recruitment, age limit, qualifications

The method of recruitment to the said post, age limit, qualifications and other matters connected therewith shall be as specified in columns (5) to (14) of the said Schedule.

4. <u>Disqualification</u>: No person, -

- [a] who has entered into or contracted a marriage with a person having a spouse living, or
- [b] who, having a spouse living, has entered into or contracted a marriage with a person,

shall be eligible for appointment to the said post:

provided that the Central Bovernment may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax:

Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in

writing relax any of the provisions of these rules with respect to any class or category of persons.

6. Baving:

Nothing in these rules shall affect reservations, relaxation of age limit and other concessions, required to be provided for the Scheduled Castes, Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

1. Short title and commencement :

- (a) These rules may be called the Department of Atomic Energy (Assistant) Recruitment (First Amendment)
 Rules, 1992.
- (b) They shall come into force on the date of their publication in the Official Gazette.
- 2. In the Schedule to the Department of Atomic Energy (Assistant)
 Recruitment Rules, 1988 :-
 - (a) For item (a) of Column 11 the following shall be substituted, namely -
 - "(A) 75% by promotion of departmental candidates by limited departmental qualifying examination."

- (b) For item (1) of Column 12 the following shall be substituted, namely -
 - "(1) Against the 75% quota Lower Division Clerks in the scale of Rs.950-20-1150-EB-25-1500 who have completed 6 years regular service in the grade or a combined 6 years regular service as Lower Division Clerk and Upper Division Clerk and have qualified in the limited departmental examination or direct recruitment examination for the post of Upper Division Clerk (Rs. 1200-30-1560-EB-40-2040) and Junior Stenographers/Upper Division Clerks and others in the grade of Rs-1200-30-1560-EB-40-2040 who have completed 3 years of regular service in the grade in the scale of Ns. 1200-00-1560-EB-40-2040 and those in the scale of Rs. 1400-40-1800-EB-50-2300, Rs.1400-40-1600-50-2300-EB-60-2600 and Rs.1640-60-2600-EB-75-2900 are eligible to take up Departmental examination."

- 1. (1) These rules may be called the Department of Atomic Energy (Assistant) Recruitment (Amendment) Rules, 1997.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. In the Schedule to the Department of Atomic Energy (Assistant) Recruitment Rules, 1988 and (First amendment) 1992,
- a) in Column 12, item (1) for the portion beginning with the words and figures "Against 75% quota", and ending with words "Departmental examination", the following shall be substituted, namely:-

- EB-25-1500 who have completed 6 years of regular service in the grade or a combined 6 years regular service as Lower Division Clerk and Upper Division Clerk and have qualified in the limited departmental examination or direct recruitment examination for the post of Upper Division Clerk (Rs.1200-30-1560-EB-40-2040);
- (ii) Upper Division Clerks / Stenographers / Telex
 Operators who have put in 3 years of regular service
 in that grade in the scale of Rs.1200-2040;
- (iii) Senior Stenographers (Rs.1400-40-1600-50-2300-EB-60-2600) Senior Clerks, Assistant Security Officers, Jr. Hindi Translators, Senior Telex Operators, Supervisor (Transport) Public Relations Assistant, Publicity Assistant, Welfare Assistant, Manager, Cashier, Caretaker in the grade of Rs.1400-40-1800-EB-50-2300;
- (iv) Personal Assistants in the grade of Rs. 1640-2900";
- (b) after the note 1, the following note shall be inserted namely:-

"Note 2: Where the juniors who have completed their qualifying eligibility service are being considered for promotion, their seniors shall also be considered provided they are not short of their requisite qualifying eligibility service by more than one year and have successfully completed their probation, if prescribed";

(c) in Column 13, for the entries, the following shall be substituted namely:-

For posts in the Department of Atomic Energy :

- 1. Director / Deputy Secretary Chairman
- 2. Deputy Secretary / Officer on Member Special Duty

For posts against 25% quota in the Bhaba Atomic Research Centre

- 1. Head, Personnel Division / Chairman Chief Administrative Officer
- 2. Chief Administrative Officer / Member Jt. Controller (Finance & Accounts)

Subject: Norms for the post of Assistant (PB-2 Rs. 9300-34800 plus Grade Pay Rs. 4200)

Reference is invited to this Department's notification No. 20/1/8/85-CCS/654 dated June 14, 1988 regarding the Recruitment Rules for the post of Assistant (PB-2 Rs. 9300-34800 plus Grade Pay of Rs. 4200).

2. The competent authority has approved amendment of item 2 under column12 of the Schedule to the Recruitment Rules for the post of Assistant (PB-2 Rs. 9300-34800 plus Grade Pay Rs. 4200) under this Department as under:-

Item 2 under column 12 of the Schedule

Promotion against 25% quota

Upper Division Clerks who have completed 6 years regular service in the grade in PB-1 Rs. 5200-20200 plus Grade Pay Rs. 2400 and Senior Clerks in PB-2 Rs. 9300-34800 plus Grade Pay Rs. 4200 are eligible to be considered for promotion on the basis of seniority-cum-fitness.

3. Action to incorporate necessary amendments in the existing Recruitment Rules and to notify the same under Article 309 is being taken separately.
