Subject: Withdrawal of DAE endorsement regarding applicability of CCS (Implementation of National Pension System(NPS)) Rules, 2021 & Notification No.G.S.R.658(E) dated 23.09.2021 regarding CCS (Payment of Gratuity under NPS) Rules, 2021 in AIs of DAE

This Department vide Endorsements referred above has forwarded the copy of CCS(Implementation of NPS) Rules, 2021 vide G.S.R.227(E) and Gazettee Notification No.G.S.R.658(E) regarding CCS(Payment of Gratuity under NPS) Rules, 2021 to all the Aided Institutions under the Department for necessary action, if applicable.

- 2. Now, DP&PW vide Office Memorandum No.28/3/2023-P&PW(B) dated 02.03.2023(copy enclosed) has clarified that the rules/instructions issued by DP&PW are not suo-moto applicable to the employees of autonomous bodies. The CCS(Implementation of NPS) Rules, 2021 have been notified to regulate service related matters in respect to Central Government Civil employees covered under NPS. Applicability of these rules to the employees of autonomous bodies needs to be decided by concerned autonomous body and administrative Department in consultation with Department of Expenditure.
- 3. Therefore, the endorsements as mentioned above in the reference stands withdrawn.
- 4. Accordingly all the Aided Institutions are hereby instructed to withdraw the benefits granted to its employees under CCS(Implementation of NPS) Rules, 2021 and CCS(Payment of Gratuity under NPS) Rules, 2021, which was endorsed by the Department vide endorsements dated 09.03.2022. Any options submitted by employees of Aided Institutions under the above said Rules shall be treated as null and void.

Subject: Clarification on applicability of CCS (Implementation of NPS) Rules, 2021 to the employees of autonomous bodies - reg.

Undersigned is directed to refer to Department of Atomic Energy's ID note No. 20/26/2021-SCS/1872 dated 09.02.2023 on the subject mentioned above and to say that Department of Pension and Pensioners' Welfare administers pension related policy matters in respect of Central Government civil employees. The service matters of the employees of autonomous bodies do not come under the jurisdiction of this Department. The rules / instructions issued by this Department are, therefore, not suomoto applicable to the employees of autonomous bodies.

2. The CCS (Implementation of NPS), Rules, 2021 have been notified by this Department to regulate service related matters in respect to Central Government civil employees covered under NPS. Applicability of these rules to the employees of autonomous bodies needs to be decided by concerned autonomous body and administrative Department in consultation with Department of Expenditure.
