NOTIFICATION

In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules regulating the method of recruitment to the post of Public Relations Assistant/Publicity Assistant in the Department of Atomic Energy, namely:-

- 1. Short title and commencement: (1) These rules may be called the Department of Atomic Energy(Public Relations Assistant/ Publicity Assistant)Recguitment Rules 1991.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. <u>Humber 6f posts</u>, classification and scale of pay: The number of the post, its classification and the scale of pay attached thereto shall be as specified in Columns 2 to 4 of the Schedules annexed to these rules.
- 3. Method of Recruitment, age limit, qualifications, etc.

 The method of recruitment to the said post, age limit,

 qualifications and other matters connected therewith shall

 be as specified in Columns 5 to 14 of the said Schedule.
- 4. Disqualification : No person, -
 - (a) who has entered into or contracted a marriage with a

person having a spouse living, or

(b) who, having a spouse living, has entered into or contracted a marriage with a person,

shall be eligible for appointment to the said post's

Provided that the Central Government may, if satisfied that

such marriage is permissible under the personal law applicable
to such person and the other party to the marriage and that
there are other grounds for so doing, exempt any person from
the operation of this rule.

- 5. Power to relax: Where the Central Government is of the opinion that it is necessary or expedient so to do it may, by order and for reasons to be recorded in writing relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving: Nothing in these rules shall affect reservations, relaxation of age limit, and other concessions required to be Ex-Serviceman provided for the Scheduled Castes, Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

PROMOTION

1. By promotion from among Upper Division Clerk and Stenographers Jr. (scale of pay &.1200-2040) who have put in a minimum regular service of 3 years in the grade and holding Degree/Diploma in Public Relations OR

UDCs/Stenographers Jr. who have put in a minimum of 5 years regular service in the grade and having experience in organising conferences, symposia, lectures and conducting visitors.

Note: 1. The selection will be made after interviewing the eligible candidates on merit basis.

Reference is invited this Notification to Department No.20/1/8/87-CC5/227 dated February 28, 1991 notifying Recruitment Rules for the post of PRA/Publicity Asstt. in the Department of Atomic Energy. In Column 12 of the schedule to the said Recruitment Rules it has been inter-alia laid down that in case of recruitment by promotion, it is to be made from among Upper Division Clerks and Stenographer Jr. (Revised scale of pay Rs.4000-6000) who have put in a minimum regular service of 3 years in the grade and holding degree/diploma in Public Relations or UDC/Stenographer Jr. who have put in a minimum of 5 years regular service in the grade and having experience in organising Conferences/Symposia/Lecturers and Conducting visitors. Inspite of the best efforts adequate number of candidate with the prescribed qualifications and experience could not be found out within the aforesaid limited zone of consideration. This aspect has been examined in the Department. It has accordingly been decided to widen the zone of consideration by including in the feeder grade LDCs who are having aptitude for Public Relations work with long experience. In view of this, Col. No.12, the clause relating to 'Promotion' indicated in the Department's aforesaid notification would now stand partially modified to the extent indicated below:-

Promotion

1. From among Upper Division Clerks and Stenographers Grade-III (Scale of pay Rs.4000-6000) who have put in a minimum regular service of 3 years in the grade and holding degree/diploma in Public Relations <u>OR</u>

Upper Division Clerks/Stenographers Grade-III (Scale of pay Rs.4000-6000) who have put in a minimum of 5 years regular service in the grade and having experience in organising Conferences, Symposia, Lectures and Conducting visitors.

2. From among Lower Division Clerks (Scale of pay Rs.3050-4590) who have put in a minimum regular service of 6 years in the grade and holding degree/diploma in Public Relations <u>OR</u>

Lower Division Clerks (Scale of pay Rs.3050-4590) who have put in a minimum of 7 years regular service in the grade and having experience in organising Conferences/Symposia/Lectures and Conducting visitors.

2. Action is being initiated to incorporate the amended norms in the existing Recruitment Rules under Article 309 of the Constitution which will be notified in due course. This order which is issued with the approval of the competent authority will come into force with immediate effect.
