### Office Memorandum

#### Subject: NER District SDG Index and Dashboard, Baseline Report 2021-22-reg.

The undersigned is directed to refer to the subject cited hereinabove. It is stated that a milestone towards localizing the Sustainable Development Goals (SDGs) was achieved with the release of the first edition of the North Eastern Region (NER) District SDG Index Report and Dashboard 2021-22 by Ministry of DoNER & NITI Aayog on 26<sup>th</sup> August 2021. The Index measures the performance of the districts of the eight States of North East on the SDGs and their corresponding targets and ranks the districts based on the same.

- 2. In the Index, the districts have been classified based on their NER District SDG Index score as Aspirant (0-49), a Performer (50-64), a Front Runner (65-99) and an Achiever (100). Due to data constraints, Index has been prepared for 103 out of 120 districts for rankings, wherein 64 districts belonged to the Front Runner category while 39 districts are in the Performer category in the composite score and ranking of districts. All districts in Sikkim and Tripura fall in the Front Runner category and there are no districts in the Aspirants or Achiever categories. The score for the 103 districts ranges from 53.00 in Kiphire (Nagaland) to 75.87 in East Sikkim.
- 3. The NER District SDG Index 2021-22 is live on an online dashboard, which has cross-sectoral relevance across policy, civil society, business, and academia. The full NER SDG Index report can be accessed at: https://wgz.short.gy/NER and the Interactive dashboard can also be accessed at https://sdgindiaindex.niti.gov.in/NER/dashboard/.
