If the officers do not report after relieving/deemed relieving, they will be treated as absenting from duty unauthorisedly and will be liable for disciplinary action besides non-drawal of salary and allowances

4. If the transferred officers wish to avail any leave after the above-said date of relief, they have to first report to the unit to which they have been transferred and the leave will have to be invariably sanctioned by the leave sanctioning authority of the unit
