Officers at Sl. No. (i), (iii), (iv), (v), (vii), (x), (xi), (xiii), (xv), (xviii), (xx), (xxiii) and (xxv) will be on probation for a period of one year from the date of assumption of charge of the post of Assistant Personnel Officer.

5. इसके अतिरिक्त, सभी सहायक कार्मिक अधिकारी जो अपने वर्तमान स्टेशन से बाहर रोटेशनल स्थानांतरण पर स्थानांतरित किए गए हैं, वे अधिकतम दिनांक 16.9.2019 तक कार्यमुक्त किए जाएं। ऐसा न करने पर वे अधिकारीगण अगले कार्यदिवस से कार्यमुक्त हो जाएंगे/कार्यमुक्त माने जाएंगे। यदि ये अधिकारी कार्यमुक्त/कार्यमुक्त माने जाने के बाद रिपोर्ट नहीं करते हैं तो वे अप्राधिकृत रूप से ड्यूटी से अनुपस्थित माने जाएंगे और वेतन और भत्तों के गैर आहरण के अतिरिक्त अनुशासनात्मक कार्रवाई के लिए भागी होंगे।

Further, all Assistant Personnel Officers transferred on rotational transfer outside their present station may be relieved latest by 16.9.2019, failing which the officers will stand relieved/deemed to be relieved from the next working day. If the officers do not report after relieving/deemed relieving, they will be treated as absenting from duty unauthorisedly and will be liable for disciplinary action besides non-drawal of salary and allowances.

6. यदि स्थानांतरित अधिकारी सेवामुक्त की उपर्युक्त तारीख के बाद कोई छुट्टी लेने चाहते हैं तो पहले वह उस यूनिट में रिपोर्ट करेंगे जिसमें उसका स्थानांतरण किया गया है और छुट्टी उस यूनिट के छुट्टी मंजूरी प्राधिकारी द्वारा निरपवाद रूप से मंजूर की जानी होगी।

If the transferred officers wish to avail any leave after the above-said date of relief, they have to first report to the unit to which they have been transferred and the leave will have to be invariably sanctioned by the leave sanctioning authority of the unit.
