**Sub : Medical facilities to the family members of the  
trainees appointed on the compassionate grounds.**



Existing scheme of Compassionate appointment have been modified by the Government vide DoPT O.M. No. F.No. 14014/2/2009-Estt(D) dated 11/12/2009, wherein it is indicated that for appointment on compassionate grounds in exceptional circumstances Government may consider recruiting persons not meeting the minimum educational standards and engage them as trainees who will be given the regular pay bands and grade pay only on acquiring the minimum qualification prescribed under the recruitment rules. The emoluments of these trainees, during this period will be in the minimum of the -1S pay band of ₹ 4440-7440 without any Grade Pay and all the applicable allowances, like DA, HRA and Transport allowance at the admissible rates on such pay.

4. A number of references have been received in the Department to extend the CHSS facility to family members of the trainees appointed on the compassionate grounds.

5. After careful consideration in the Department, it has now been decided to provide the CHSS facility to the eligible family members of the trainees who have appointed on the compassionate grounds in terms of the provisions contained in DoPT O.M. No. F.No. 14014/2/2009-Estt(D) dated 11/12/2009, as long as they continue as trainee in the department.
