Rule No.2.1.10(ii) 1.

Rate of recovery in respect of those retired prior to 1.1.96 after Jan.-96 and upto 1.2.98.

With effect from 1.2.98.

1 % of basic pay as envisaged under the Scheme to be levied.

b) Rate of contribution in respect of those retired and having taken re-employed or not, after up re-employment.

2. Rule 2.1.10(iii)

5. Rule 4.1(b)

Whether children above 25 years of age and suffering from regular psychiatric disorder and other ailments will be eligible to have treatment under this Scheme.

Deserving cases can be considered for special relaxation by DAE on the basis of an application from the parent with specific recommendation by the Head, Medical Division, BARC.

6. General

Whether reimbursement is admissible for treatment availed of between the expiry date of membership and subsequent renewal. No re-imbursement under the Scheme is admissible during the interregnum of expiry of the membership and renewal thereof.
