OFFICE MEMORANDUM

Sub : Introduction of Contributory Health Service
Scheme (CHSS) facilities at HWP, Tuticorin.

A proposal for extension of Contributory Health Service Scheme(CHSS) coverage to the employees of DAE Units located at Tuticorin has been under consideration in the Department for some time. The President is now pleased to approve extension of the CHS Scheme of this Department in operation in Mumbai as notified vide DAE Office Memorandum No.7/55/94/CHSS/IR&W/37 dated January 22, 1998 mutatis-mutandis to the officers and staff, their family members and dependents in the DAE establishments at Tuticorin with immediate effect subject to the following :

1. The Scheme will cover the following Units/Organisations located at Tuticorin :
 - i) Heavy Water Plant
 - ii) Directorate of Purchase & Stores
 - iii) Any other Units/Institutions/Organisations to be notified by DAE from time to time.
2. The introduction of the Scheme at Tuticorin would not entail any further additions to the existing medical infrastructure including hospitals, dispensaries, equipment or manpower.
3. The Scheme will come into force with immediate effect and will be administered by Chief Executive, HWB on the advice of Head, Medical Division, BARC, wherever necessary especially in regard to recognition of hospitals/nursing homes in addition to the six as proposed now.
4. The salient features of the Scheme and the procedural formalities for availing of the treatment/appointment of AMAs, etc. would be as contained in the HWB ID Note No.HWB/IRS/4(10)(1)/397 dated May 24, 1996.

5. A separate budget provision will have to be made for the facilities to be given under CHSS from 1.4.1999. However the expenditure to be incurred upto 31.3.99 will have to be met out of the budgetary provision made under Salaries Establishment expenses in respect of HWB.

This issues with concurrence of Member for Finance Atomic Energy Commission.
