OFFICE MEMORANDUM

Sub: Introduction of Contributory Health Service Scheme (CHSS) facilities at VECC, Calcutta.

A proposal for extension of Contributory Health Service Scheme(CHSS) coverage to the employees of DAE Units located at Calcutta has been under consideration in the Department for some time. The President is now pleased to approve extension of the CHS Scheme of this Department in operation in Mumbai as notified vide DAE Office Memorandum No.7/55/94/CHSS/IR&W/37 dated January 22, 1998 mutatis-mutandis to the officers and staff, their family members and dependents in the DAE establishments at Calcutta with immediate effect subject to the following:

- 1. The Scheme will cover the following Units/Organisations:
 - i) Variable Energy Cyclotron Centre
 - ii) Atomic Minerals Division
 - iii) Directorate of Purchase & Stores
 - iv) Directorate of Construction Services & Estate Management
 - v) Board of Radiation and Isotope Technology
 - vi) Nuclear Power Corporation of India Ltd.
 - vii) Any other Units/Institutions/Organisations to be notified by DAE.
- The introduction of the Scheme at Calcutta would not entail any further additions to the existing medical infrastructure including hospitals, dispensaries, equipment or manpower.
- The Scheme will be administered by Director, VECC on the advice of Head, Medical Division, BARC, wherever necessary.
- The procedural formalities for managing the Scheme and for recognition of hospitals/appointments of AMAs etc. will be the responsibility of Director, VECC.

- 5. The salient features and procedural formalities for availing of the treatment, etc. would be as contained in the proposal submitted by VECC vide letter No.VECC/5631 dated 20.09.1996. The base hospital for administering the Scheme will be the Assembly of God Hospital and Research Centre or as notified by Director, VECC in future. However, continuance of existing referral hospitals as also recognition of any other hospital(s) will be reviewed/decided in consultation with Head, Medical Division, BARC.
- 6. A separate budget provision will have to be made for the facilities to be given under CHSS from 1.4.1999. However, the expenditure to be incurred from 1.9.98 to 31.3.99 will have to be met out of the budgetary provision made under Salaries/Establishemnt expenses in respect of VECC.

This issues with concurrence of Member for Finance, Atomic Energy Commission.
