## DEELCE DEMOCANDUM

The undersigned is directed to convey the approval of the President for the extension of the Contributory Health Services Scheme of the Department of Atomic Energy in operation in Greater Bombay vide this Department's O.M. No. 32(5)/69-Adm., dated April 21, 1975 as amended from time to time <u>eutatis</u> <u>eutandis</u> to the Officers, Staff and their family members and dependents of Tata Memorial Centre located in Greater Bombay with effect from 1.1.1995 subject to the following conditions:—

- An option will be given to all employees of the TMC for admission to the Scheme.
- Existing employees who do not opt initially for the CHSS will not be admitted at any future date.
  - 3) TMC will pay in advance to the Scheme an amount equivalent to per-capita expenditure per beneficiary in respect of their employees joining the Scheme.
  - 4) It shall be the responsibility of the TMC to recover from the employees the amount of the subscription which will be retained by TMC.
  - 5) The TMC employees will be governed by the rules and regulations of CHSB of DAE.
  - 6) Priority shall be given for in-patient and out-patient treatment for all CHSS beneficiaries at Tata Memorial Hospital.
  - 7) The number of employees would be strictly limited to the data provided by TMC, as shown in the Annexure. Subject to this, new entrants to the service of TMC may be admitted into this Scheme, in case they exercise an option within a period of one month of their joining service.

8) The Scheme will be in force initially for a period of 2 years after which a review will be conducted for enabling a final decision.
