Sub.: Terms and Conditions for admission of ppersonnel of the Indian Rare Earths Ltd., to the benefits of the Contributory Health Service Scheme of the Department.

Sir,

I am directed to refer to the correspondence resting with IRE letter Ne.322-(A)/9314/72 dated Decamber 7, 1972 addressed to the Head, Medical Division, Ehabha Atomic Research Centrez on the above subject and to state that the President has been pleased to decide that the officers and employees of Indian Rare Earths Ltd., may be admitted to the benefits of the Contributory Health Service Scheme of this Department with effect from April 1, 1973 on the terms and conditions spelt out in the Annexure to this letter. Any modifications to the Contributory Health Service Scheme, as and when made, will be applicable mutatis-mutandis to the Indian Rare Earths Limited employees also.

- 2. The above arrangement is further subject to the fellowing conditions.:
 - (a) All IRE employees will be given and option and those who opt for the CHSS of the Department will be admitted with effect from 1st Arpil, 1973 and will not be allowed to opt out of the Scheme excepting once during their service with the company and that too only with effect from the beginning of the financial year. Any employee going out of the scheme will not be readmitted.
 - (b) Existing employees who do not opt initially for the CHSS of the Department will not be admitted any any futuredate.
 - (c) New entrants to the service of the company may be allowed to exercise the option within a period of one month of their joining. The conditions as in (a) above will be applicable to the new entrants also for opting out of the scheme.

3. It is, therefore, requested that a list of the existing employees indicating their designation, scale of pay and basic pay who opt for the Scheme may be sent to the Director, Bio-Medical Group, BARC to whom a copy of this letter is being endorsed, under intimation to this Department.
