I am to invite reference to Ministry of Finance, Department of Expenditure OM No.F.20/42/2021-PPD dated 1<sup>st</sup> September, 2021 under which special provisions for Scientific Ministries/Departments in the General Financial Rules, 2017 have been prescribed.

2. At the outset, I would like to state that the special provisions have indeed been of great help to the Scientific Ministries and have gone a long way in easing the procurement processes for projects being executed by the Ministries/Departments and their laboratories.

3. As you may be aware, a good part of the scheme budget of the Science Ministries/Departments, particularly the Department of Science and Technology and the Department of Biotechnology, is devoted to extramural funding of research projects. A large number of such projects are given to higher education institutions under the Ministry of Education for cutting edge research and development. Since the provisions made in the ibid OM of the Department of Expenditure are applicable only to Science Ministries/Departments, the higher education institutions under the Ministry of Education are not covered, even where the funding is by the Science Ministries/Departments.

4. We have received requests from several such institutions requesting that the provisions contained in the ibid OM may be extended to them also for projects funded by the seven Science Ministries/Departments i.e. DST, DBT, DSIR, DAE, DOS, MoES and DRDO.

5. May I request you to consider the above request favourably and extend the ibid special provisions to the projects funded by Scientific Ministries/Departments to institutions under the Department of Higher Education, Ministry of Education. It will be a major step towards ease of doing science and is going to be of immense benefit to the scientific community, leading to larger public good.

#### OFFICE MEMORANDUM

### Subject: Special provisions for Scientific Ministries/ Departments in General Financial Rules, 2017.

NITI Aayog has collated inputs from various scientific Ministries/ Departments regarding the provisions in General Financial Rules (GFRs) 2017 that impede the smooth functioning of these Ministries/ Departments. NITI has further recommended/ suggested certain changes in GFRs based on these inputs.

#### 2. In this context, following amendments in GFRs are being made:-

Rule No.	Existing	Amended GFR
133(3)	As an alternative to 133(2), a Ministry or Department may award repair works estimated to cost above Rupees thirty Lakh and original works of any value to: (i)any Public Sector Undertaking (PSU) set up by the Central or State Government to carry out civil or electrical works or (ii)to any other Central/ State Government organisation/ PSU which may be notified by the Ministry of Urban Development (MoUD) for such purpose after evaluating their financial strength and technical competence.
