(ii) 10 years' experience in the field of analytical work of organic material, or in the field of Marketing of Milk and Milk Products, Oils and Fats including Essential Oils and allied commodities.

OR

8 years' experience in the field of analytical work of organic material, or in the field of Marketing of Milk and Milk Products, Oils and Fats including Essential Oils and allied commodities with diploma in Marketing Management awarded by the Indian Institute of Food Technology or equivalent or any other recognized university/Institute or equivalent.
