- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. - 1. The Firm/Agency should be a registered as a Proprietary firm/Partnership firm/Registered company. In c ase of Partnership firm, a certified copy of partnership deed and current address of all the partners shall ac company the Tender application bid. In case of Limited company, satisfactory evidence of its existence shall accompany the tender Bid.
- 2. The Firm/Agency must have Copy of the Pan Card.

- 3. The Firm/Agency must have Copy of Valid EPF registration certificate & Latest Paid Challan.
- 4. The Firm/Agency must have Copy of ESIC registration certificate & Latest Paid Challan.
- 5. The Firm/Agency must have Copy of PT registration certificate & Latest Paid Challan.
- 6. The Firm/Agency must have the Copy of MLWF registration certificate & Latest Paid Challan.
- 7. The Firm/Agency must have GST registration certificate (Since July 2017) & Latest Paid Challan.

- 16. The Firm/Agency should have to Submit Solvency Certificate of minimum Rs. 30 Lakhs, not older than 6 months.
- 17. All the above mentioned documents must be uploaded on GeM Portal by the bidders.

19. - 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
