I am directed to say that the National Commission for Scheduled Tribes, a Constitutional body under Article 338A of the Constitution of India, proposes to fill up three vacancies of Upper Division Clerk, Group 'C', Level 4 (Rs. 25500-81100) the 7th CPC Pay Matrix, on deputation basis. Two vacancies are located at the NCST HQs, New Delhi and one at Regional Office, Bhubaneswar (Odisha).

2. Job requirements, experience and qualifications required for the post are as under:

Officers under the Central Government or State Governments or Union territory Administration or Universities or recognised research institutions or public sector undertakings or autonomous, Semi–Government or statutory organisations-

(a) (i) holding analogous post on regular basis in the parent cadre or department; or
 (ii) with five years' service in the grade rendered after appointment thereto on a
 regular basis in the posts in level 2 in the pay matrix (Rs.19900-63200) in the parent
 cadre or department; and

(b) possessing the educational qualifications and experience as under:

(1) 12th Class or its equivalent/qualification from a recognized Board or University.

(2) Minimum typing speed of 35 words per minute in English or 30 words per minute in Hindi on computer.

Note 1: The departmental officers in the feeder category who are in direct line of promotion shall not be eligible for consideration for appointment on deputation.

Note 2: Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not to exceed four years.

Note 3: The maximum age-limit for appointment by deputation shall not be exceeding fifty-six years as on the closing date of receipt or applications.
