- 1) The 'Halwai-cum-Cook' shall perform the services as assigned by the controlling officer.
- 2) The normal working hours would be from 9.30 am to 6:00 p.m. with lunch break of 30 minutes from 1:30 p.m. to 2.00 p.m. from Monday to Friday.
- 3) The 'Halwai-cum-Cook' shall be entitled to 1.5 days of leave for every completed month of service during a period of one year of engagement to be availed with prior permission.
