The Department of Atomic Energy (DAE) is looking for an eminent scientist of international repute for appointment as Director in the Saha Institute of Nuclear Physics (SINP), Kolkata. SINP is a premier Institute dedicated to high level basic research in Physical and life sciences. The Institute has major programmes in nuclear and particle physics, material science, bioscience and others. Experimental research forms an important aspect of activities at SINP. SINP is an Autonomous Institution fully funded by DAE and is widely recognised for its excellence in scientific research.

**Scale of Pay of the post**

The scale of pay of the post of Director, SINP is **Level 16 in Pay Matrix as per 7<sup>th</sup> CPC** plus allowances as per rules of the Government of India/Bye-laws of the SINP.

**Tenure of the post**

The tenure of the appointment will be for five years from the date of appointment or until 60 years of age, whichever is earlier, which may be extended at the discretion of the Governing Council of SINP with the approval of the Government of India.

### **Nature of Duties**

- The Director, SINP is the Academic as well as the Administrative Head of the Institute. He /She shall be overall responsible for carrying out the functions and responsibilities assigned to SINP by Government of India or the Governing Council of SINP. He/She shall be responsible to manage the human and financial resources of the Institute.
- He/She will be the Head/Member/Invitee of such Bodies/Agencies/ Organisations/Committees as decided by Government of India or the Governing Council of SINP from time to time.
- He/She shall guide and motivate the team of Scientists/Academics and other personnel of the Institute. He shall be responsible for the implementation of various research programmes / projects by optimum utilization of available resources.
- He/She shall perform the duties in accordance with the bye-laws/rules of the Institute and rules/directives from Government of India from time to time. He/She shall be under the Administrative control of the Governing Council of the Institute.
- He/She shall assign duties to all the employees of the Institute as per the bye-laws/rules and shall exercise supervision and control as prescribed in the bye-laws/rules.
- He/she shall exercise such financial powers as delegated to him/her by the Governing Council in consultation with Government of India, where necessary.
- He/She shall be the Disciplinary Authority in respect of such set of employees as prescribed under bye-laws/rules.

### **Eligibility criteria :**

- **Age :** Candidate shall not be less than 50 years of age and shall not be more than 57 years of age as on the closing date of receiving application i.e. 31.01.2026.

- **Educational Qualification:** The candidate should be a Ph.D with first class or equivalent at preceding degree in the appropriate branch. Eminent Scientist or a person with an outstanding record as well as impressive R&D track record in any of the fields pursued at SINP shall be preferred.
- **Essential Experience:**
- Already in Analogous Pay Level (16) or 5 years experience in Pay Levels 14 & 15 (Combined) in Pay Matrix as per 7<sup>th</sup> CPC in managing a large scientific community in the execution of projects or heading a reputed scientific institution.
- He/She should have an excellent publication record, experience of leading a group, national and international recognition etc.
- He/She should have rich experience in project implementation with optimum utilization of resources.
- **Desirable:** Apart from the above essential qualifications, the candidate is expected to be familiar with administrative and financial matters, preferably in Government. Candidate with experience in Managerial capacity in a large research laboratory shall be preferred. He/she should have the national/international recognition (members of national/international academies, prestigious national/international awards etc)

#### **Selection procedure:**

Appointment will be made by the Government of India on the recommendations of a Search-cum-Selection Committee. The Search-cum-Selection Committee constituted for the purpose of selection of the Director will consider applications received in response to this advertisement as well as nominations received from eminent persons.

### **Application Procedure :**

Interested individual may apply giving detailed Resume in the prescribed proforma along with one page Vision statement for the Institute.
