



SANCTION ORDER

Sanction of the Competent Authority is hereby accorded to the payment of Rs. 9,99,200/- (Rupees Nine Lakhs Ninety-nine thousand and two hundred only) to Chanakya National Law University, Patna towards **Second Installment** (being 40% of total project cost of Rs. 24,98,000/- (Rupees Twenty Four Lakh Ninety Eight thousand only) for undertaking research project titled "Impact Assessment of Commercial Courts Act, 2015 with reference to Commercial litigations pending in State of Bihar & Jharkhand" as per the terms of the agreement signed by Chanakya National Law University, Patna and Department of Justice on 6th November, 2019. 1st installment of Rs. 4,99,600/- (Rs Four Lakhs Ninety Nine Thousand Six Hundred Only) is payable to the Implementing Agency.
