
SANCTION ORDER

Sanction of the Competent Authority is hereby accorded to the payment of Rs. 7,270/- (Rupees Seven Thousand Two Hundred and Seventy only) to J&K State Judicial Academy, Jammu/Srinagar towards Fourth and Final Installment, out of the total project cost of Rs.19,64,600/- (Rupees Nineteen Lakhs Sixty Four Thousand Six Hundred only) for undertaking research project titled "Physical verification of case files of two districts, Udhampur and Budgam of Jammu and Kashmir with the data on pendency available on National Judicial Data Grid (NJDG) to identify causes for pendency and map a way forward to reduce delay and introduce effective data collection mechanisms. Identifying the bottlenecks responsible for causing delay in disposal of civil cases in courts and possible policy and procedural changes necessary for reduction of pendency and a study on Court Management techniques for improving the efficiency of subordinate courts" submitted by J&K State Judicial Academy under the Scheme of Action Research and Studies on Judicial Reforms and as per the terms of the agreement signed by J&K State Judicial Academy, Jammu/Srinagar and Department of Justice on 23rd April, 2018. First, Second and Third installment of Rs. 3,92,920/- (Rupees Three Lakh Ninety Two Thousand Nine Hundred and Twenty Only); 7,85,840/- (Rupees Seven Lakh Eighty Five Thousand Eight Hundred and Forty Only) and two part instalments of Rs.3,24,045/- (Rupees Three Lakh Twenty Four Thousand and Forty Five only) & 2,13,172/- (Rupees Two Lakh Thirteen Thousand One Hundred Seventy Two only) respectively have been released to the Implementing Agency vide Orders of even no. dated 23.04.2018, 22.03.2019, 26.03.2020 and 22.05.2020

2. The expenditure involved is debitable to Demand No.64 during 2021-22 (Non-Scheme), Major Head 2052-Secretariat General Services-090-Secretariat, 08-Department of Justice, 08.0031-Grant-in-Aid.
