Minutes of the 12th Meeting of the "Project Sanctioning Committee (PSC)" of the "Scheme of Action Research and Studies on Judicial Reforms" held on 15th February 2019 under Chairmanship of Secretary (Justice) in Conference Room, Department of Justice Jaisalmer House, New Delhi.

The 12th meeting of the 'Project Sanctioning Committee (PSC)' to consider Action Research Project Proposals received under 'Scheme for Action Research and Studies on Judicial Reforms' was held on 15th February 2019 at Jaisalmer House, New Delhi under the Chairmanship of Dr. Alok Shrivastava, Secretary (Justice). The list of participants is at **Annexure - I.**

Secretary (Justice) welcomed all the members of the Project Sanctioning Committee (PSC) and requested Joint Secretary & Mission Director of National Mission for Justice Delivery and Legal Reforms to initiate discussion on the proposals.

All 18 proposals alongwith their one-page summary sheets of every proposal were sent to all Members of the Project Sanctioning Committee (PSC) well in advance through email as well as in hard copies. After discussions on each of the proposal, following decisions were taken.

(iii) and (iv) relating to consultation fees for Vice Chancellor and Registrar; (xiii) relating to institutional fee in view of (xii) miscellaneous; either of the two i.e. (vii) for stationary and communications, and (x) for report writing, printing and submission under the Proposed Budget; and University will be requested to explain the no. of internal and external experts under item (v) of the Budget. In addition, the study should come out with the affects before and after litigation. |
| 3. | "Research study on improving effectiveness of Gram Nyayalayas and accelerating the implementation of Gram Nyayalayas Scheme" submitted by National Productivity Council, New Delhi | The Committee after deliberations did not approve the proposal, as similar studies have already been carried out by other institutes / organisations. |

The Committee also decided to ask University to reduce the duration of the course to 12 months and to reduce the project cost accordingly. |
| 6. | "Tribunal reforms: A study of the Infrastructure, Recruitment and operational challenges faced by Central Tribunals". submitted by Vidhi Centre for Legal Policy, New Delhi. | The Committee after deliberations did not approve the proposal as there is already a Report of Law Commission on the subject. |
| 7. | "Consolidating the discourse on `All India Judicial Service". submitted by Vidhi Centre for Legal Policy, New Delhi. | The Committee after deliberations did not approve the proposal as there is no consensus of High Courts on the subject. |
| 8. | "What does India litigate ? :A study to understand the nature of legal disputes being initiated by Indian citizens across the country" submitted by Vidhi Centre for Legal Policy, New Delhi. | The Committee after deliberations did not approve the proposal as the analysis of NJD G data does not seem require legal expertise. |
| 9. | "A field study to evaluate the efficacy of Access to Justice for Under-trials in selective prisons in the specific States". submitted by National Law University, Delhi. | The Committee after deliberations approved the proposal, subject to the condition that details regarding framework and usage of pilot shall be mentioned in the revised proposal. |
