



SANCTION ORDER

Sanction of the Competent Authority is hereby accorded to the payment of Rs. 9,54,000/- (Rupees Nine Lakh Fifty Four thousand only) towards Third & Fourth and Final Installment, equivalent to the share of 30% (Third instalment of Rs. 7,15,500/-) and 10% (Final Instalment of Rs. 2,38,500/-) of total project cost of Rs.23,85,000/- (Rupees Twenty Three Lakh Eighty Five Thousand only) to Indian National Bar Association, New Delhi for undertaking research project titled "Assessing the Gaps in Criminal Justice Delivery System and its impact in Uttar Pradesh and West Bengal" submitted by Indian National Bar Association New Delhi under the Scheme of Action Research and Studies on Judicial Reforms and as per the terms of the agreement signed by Indian National Bar Association, New Delhi and Department of Justice on 14<sup>th</sup> October, 2019. First and Second installment of Rs. 4,77,000/- (Rupees Four Lakh Seventy Seven Thousand Only); 9,54,000/- (Rupees Nine Lakh Fifty Four thousand only) respectively have been released to the Implementing Agency vide Orders of even no. dated 14.10.2019 and 12.03.2020.

2. The expenditure involved is debit to Demand no.64 during 2021-22 (non-scheme) Major Head 2052-Secretariat General Services-090-Secretariat, 08-Department of Justice, 08.0031-Grant-in-Aid.
