SANCTION ORDER

Sanction of the Competent Authority is hereby accorded to the payment of Rs. 1,30,000/- (Rupees One Lakh Thirty thousand only) to Indian Institute of Management Kashipur towards Fourth and Final Installment, being 10% of total project cost of Rs. 13,00,000/- (Rupees Thirteen lakhs only) for undertaking research project titled "Global Practices in Continuing Legal Education: Emerging Platforms for Professional Development of Advocates" submitted by Indian Institute of Management Kashipur under the Scheme of Action Research and Studies on Judicial Reforms and as per the terms of the agreement signed by Indian Institute of Management Kashipur and Department of Justice on 8th November, 2018. First, Second and Third installment of Rs. 2,60,000/- (Rupees Two Lakh Sixty Thousand Only); 5,20,000/- (Rupees Five Lakh Twenty Thousand Only) and Rs. 3,90,000 (Rupees Three Lakh ninety Thousand only) respectively have been released to the Implementing Agency vide Orders of even no. dated 8.11.2018, 6.03.2019 and 29.01.2021.
