**SANCTION ORDER**

Sanction of the Competent Authority is hereby accorded to the payment of Rs. 3,52,967/- only (Rupees Three Lakhs Fifty Two Thousand Nine Hundred Sixty Seven Only) to Delhi Judicial academy, New Delhi towards **Second Instalment** (being proportionate 40% amount out of revised total cost of Rs. 13,43,143/-) out of the total project cost of Rs. 13,43,143/- (revised budget) (Rupees Thirteen Lakhs Forty Three Thousand One Hundred Forty Three Only) (non-recurring expenditure) for under taking research project titled "To identify the 'Reasons' for delay in disposal of cases and evaluate 'Capacity Gap' to manage the pendency of cases in District & Subordinate Courts of Delhi" under the "Scheme of Action Research and Studies on Judicial Reforms" as per the terms of the agreement signed by Delhi Judicial academy, New Delhi and Department of Justice on 28<sup>th</sup> February, 2018. 1<sup>st</sup> Installment of Rs. 4, 52,919/- have been released vide order of even no. dated 28.02.2018.
