
SANCTION ORDER

Sanction of the Competent Authority is hereby accorded to the payment of Rs. 10,00,000/- only (Rupees Ten Lakhs Only) to National Law University, Delhi towards **Second Installment** (being 40% out of the total project cost of Rs. 25,00,000/-) (non-recurring expenditure) for undertaking research project titled "Empirical study to evaluate the delivery of justice through improved infrastructure" submitted by National Law University, Delhi vide letter Ref. NLU/CTAG/2018 dated 10.12.2018 (revised) under the Scheme of Action Research and Studies on Judicial Reforms and as per the agreement signed by National Law University, Delhi and Department of Justice on 22nd January, 2019. 1st Instalment of Rs. 5,00,000/- has been released vide order of even no. dated 22.01.2019. The implementing agency is requested to adhere to the timeline mentioned in the approved proposal and agreement dated 22.01.2019.
