
**SANCTION ORDER**

Sanction of the Competent Authority is hereby accorded to the payment of Rs. 3,50,644/- only (Rupees Three Lakhs Fifty Thousand Six Hundred Forty Four Only) to National Institute of Technology, Rourkela towards **Third Installment** (being 30% out of the total project cost of Rs. 21,28,650/- after deducting unspent balance shown in Utilization Certificate dated 17.01.2020 ) (non-recurring expenditure) for undertaking research project titled "A Study of Cheque-bounce cases under Negotiable Instruments( NI) Act 1881" submitted by National Institute of Technology, Rourkela vide letter dated 05.12.2018 ( revised) under the Scheme of Action Research and Studies on Judicial Reforms and as per the agreement signed by National Institute of Technology, Rourkela and Department of Justice on 29<sup>th</sup> January, 2019.1<sup>st</sup> installment of Rs. 4,25,730/- and 2<sup>nd</sup> installment of Rs. 8,51,460/- has been released vide orders of even no. dated 29.01.2019 and 13.08.2019 respectively.
