



SANCTION ORDER

Sanction of the Competent Authority is hereby accorded to the payment of Rs. 10,00,000/- only (Rupees Ten Lakhs Only) to National Law University, Delhi towards **Second Installment** (being 40% out of the total project cost of Rs. 25,00,000/-) (non-recurring expenditure) for undertaking research project titled "A Field Study to Evaluate the Efficacy of Access to Justice for Under Trials in selective prisons in the specific States" submitted by National Law University, Delhi vide Email dated 08.03.2019 (revised proposal) under the Scheme of Action Research and Studies on Judicial Reforms and as per the agreement signed by National Law University, Delhi and Department of Justice on 22nd March, 2019. 1st Instalment of Rs. 5,00,000/- has been released vide order of even no. dated 22.03.2019. The implementing agency is requested to adhere to the timeline mentioned in the approved proposal and agreement dated 22.03.2019.

2. The expenditure involved is debitable to Demand No. 61 during 2019-20 (Plan) under MH 2014-Administration of justice, 17-National Mission for Justice Delivery and Legal Reforms; 17.02-Action Research and Studies on Judicial Reforms, 17.02.28-Professional Services.
