SANCTION ORDER

Sanction of the Competent Authority is hereby accorded to the payment of Rs. 7,50,000/- only (Rupees Seven Lakhs Fifty Thousand Only) to National Law University, Delhi towards **Third Installment** (being 30% out of the total project cost of Rs. 25,00,000/-) (non-recurring expenditure) for undertaking research project titled "Evaluation of functioning of Fast Track Courts in India- An Empirical Study" submitted by National Law University, Delhi vide Email dated 17.08.2018 (revised) under the Scheme of Action Research and Studies on Judicial Reforms and as per the agreement signed by National Law University, Delhi and Department of Justice on 04th October, 2018. First Installment of Rs. 5,00,000/- and Second installment of Rs. 10,00,000/- was released to the implementing agency vide Saction Order of even nos. dated 04.10.2018 and 27.03.2019 respectively. The implementing agency is requested to adhere to the timeline mentioned in the approved proposal and agreement dated 04.10.2018.
