
**SANCTION ORDER**

Sanction of the Competent Authority is hereby accorded to the payment of Rs. 6,07,200/- only (Rupees Six Lakhs, Seven Thousand Two Hundred Only) to Indian Institute of Technology, Kharagpur towards **Second Installment** (being 40% out of the total project cost of Rs. 15,18,000/-) (non-recurring expenditure) for undertaking research project titled "Court-Referred Mediation in the States of West Bengal and Jharkhand" submitted by Indian Institute of Technology, Kharagpur vide letter No. IIT/SRIC/DEAN/2018 dated 22.05.2018 under the Scheme of Action Research and Studies on Judicial Reforms and as per the agreement signed by Indian Institute of Technology, Kharagpur and Department of Justice on 24<sup>th</sup> October, 2018. 1<sup>st</sup> installment amounting to Rs. 3,03,600/- was released to the implementing agency vide order dated 24.10.2018.
