SANCTION ORDER

Sanction of the Competent Authority is hereby accorded to the payment of Rs. 10,00,000/- only (Rupees Ten Lakhs Only) to Guru Gobind Singh Indraprastha University, Delhi towards **Second Installment** (being 40% out of the total project cost of Rs. 25,00,000/- (Rupees Twenty Five Lakhs Only) (non-recurring expenditure) for undertaking research project titled "Analysis of lack of Infrastructure and vacancies and its impact on pendency in Subordinate Courts: A study of Delhi, Punjab and Haryana" submitted by Guru Gobind Singh Indraprastha University, Delhi under the Scheme of Action Research and Studies on Judicial Reforms and as per the agreement signed by Guru Gobind Singh Indraprastha University, Delhi and Department of Justice on 26th March, 2019. 1st Instalment of Rs. 5,00,000/- only has been released *vide* order of even no. dated 25.03.2019.
