



**SANCTION ORDER**

Sanction of the Competent Authority is hereby accorded to the payment of Rs. 3,98,000/- only (Rupees Three Lakhs Ninety Eight Thousand Only) to National Judicial Academy Bhopal towards **First Installment** (being 20%) out of the total project cost of Rs. 19,90,000/- (Rupees Nineteen Lakhs Ninety Thousand Only) (non-recurring expenditure) for undertaking research project titled "An analysis of Pendency of cases in Family Courts of Madhya Pradesh and methods to Reduce Pendency" submitted by National Judicial Academy Bhopal vide letter no.
