
SANCTION ORDER

Sanction of the Competent Authority is hereby accorded to the payment of Rs. 2,86,000/- only (Rupees Two lakh Eighty Six Thousand Only) to Gujarat National Law University, Gandhinagar towards **Second Installment** (being 40%) out of the total project cost of Rs. 7,15,000/- (Rupees Seven Lakhs Fifteen Thousand Only) (non-recurring expenditure) for under taking research project titled "Resolving pending cases through Alternative Dispute Resolution under section 89 of Civil Procedure Code: a Case Study" under the "Scheme of Action Research and Studies on Judicial Reforms" as per the terms of the agreement signed by Gujarat National Law University, Gandhinagar and Department of Justice on 19th March, 2018. First installment of Rs. 1,43,000/- (Rupees One Lakh Forty Three Thousand Only) was released to Gujarat National Law University, Gandhinagar vide this Department's Sanction Order of even no. dated 19.03.2018. The implementing Agency is requested to adhere to the timeline given in the terms of Agreement dated 19th March, 2018.

2. The expenditure involved is debitible to Demand No. 61 during 2018-19 (Plan) under MH 2014-Administration of justice, 17-National Mission for Justice Delivery and Legal Reforms; 17.02-Action Research and Studies on Judicial Reforms, 17.02.28-Professional Services.
