



SANCTION ORDER

Sanction of the Competent Authority is hereby accorded to the payment of Rs. 8,00,000/- only (Rupees Eight Lakhs Only) to Guru Gobind Singh Indraprastha University, Delhi towards **Second Installment** (being 40%) out of the total project cost of Rs. 20,00,000/- (Rupees Twenty Lakhs Only) (non-recurring expenditure) for under taking research project titled "Analysis of functioning of Legal Aid Cells in various Law Schools/University Departments/Private Universities" under the "Scheme of Action Research and Studies on Judicial Reforms" as per the terms of the agreement signed by Guru Gobind Singh Indraprastha University, Delhi and Department of Justice on 05th December, 2017. First installment of Rs. 4, 00,000/- (Rupees Four Lakhs Only) was released to Guru Gobind Singh Indraprastha University, Delhi vide this Department's Sanction Order of even no. dated 06.12.2017. The implementing Agency is requested to adhere to the timeline given in the terms of Agreement dated 05th December, 2017.
