


**SANCTION ORDER**

Sanction of the Competent Authority is hereby accorded to the payment of Rs. 8,13,600/- (Rupees Eight Lakh Thirteen Thousand Six Hundred) Only to Odisha Judicial Academy, Cuttack towards Second installment (40%) of the total project cost of Rs. 20,34,000/- (Rupees Twenty Lakh Thirty Four Thousand Only) for undertaking project proposal titled "An Analysis of the functioning of Lok Adalats in the Eastern Region of India" submitted *vide* their letter No. O.J.A. 1378 dated 16.12.2015 under the "Scheme of Action Research and Studies on Judicial Reforms" and as per the Agreement signed by Odisha Judicial Academy, Cuttack and Department of Justice on 29<sup>th</sup> June, 2016. First installment of Rs. 4,06,800/- (Rupees Four Lakh Six Thousand Eight Hundred) Only was sanctioned to the implementing Agency *vide* order of even no. dated 29<sup>th</sup> June, 2016.
